Reported out in Open Session on November 1, 2005: City Attorney Michael Aguirre announced that the San Diego City Council adopted a motion appointing Paul Jacobs as the Special Counsel to the City authorizing no more than \$100,000 for his retention. It also established a Chargers Negotiating Committee. On that Committee the Council authorized the service of Mr. Jacobs; two members from the City Council, Council Members Frye and Peters; identified Council Member Tony Young as an Alternate Member of the Committee; also appointed the City Auditor or a representative from the City Auditors Office; identified the City Attorney as a member of the Committee; and the Mayor, or the representative of the Mayor upon the Swearing-In of the new Mayor.
