Reported out in Open Session on October 10, 2006, by Karen Heumann, Assistant City Attorney:
Today in Closed Session, *In the Matter of Friends of Fox Canyon Park vs. City of San Diego*, the City Council voted to approve a settlement offer by the Petitioners which requires the City to docket rescission of the Site Development Permit and the Mitigated Negative Declaration for the Fox Canyon Park and Road Project. If the Site Development Permit and the Mitigated Negative Declaration are rescinded, the lawsuit will be dismissed in its entirety and the City will pay petitioner \$5,000 in legal fees to resolve the litigation. Motion by Councilmember Madaffer; second by Councilmember Atkins. The vote was 6-1 with Council President Peters voting No and Councilmember Maienschein not present.

Today in Closed Session, regarding the *Real Property Negotiations for the South Chollas Land Fill*, the City Council voted unanimously 7-0, to formally terminate negotiations with Paragon Practice Park, LLC and to prepare and expedite a request for proposals for recreational use, of the South Chollas Land Fill site, which will bring value to the community and be compatible with both the closed landfill and potential power production facilities at or near the site. This RFP Process is to be timed with the nine-month grading project that is planned at that site to ensure that the RFP Process is completed at the earliest possible time. The motion was by Councilmember Young; second by Councilmember Madaffer; Councilmember Maienschein not present.
