Item CS-2: City of Sun Diego v. Sun Diego City Employees Retirement System

San Diego Superior Court Case No. 37-2007-00081912-CU-WM-CTL

On April 15, 2008, in Closed Session Item CS-2, *City of Sun Diego v. Sun Diego City Employees Retirement System*, San Diego Superior Court Case No. 37-2007-00081912-CU-WM-CTL, on a motion to authorize the filing of the action, the City Council voted 4 to 1 (80 percent in favor - 20 percent in opposition), to provide the City Attorney permission to initiate and maintain the action against non-retirees. The motion made by Councilmember Faulconer and seconded by Councilmember Frye. Councilmembers Faulconer, Frye, Young, and Council President Peters voted "yes," and Councilmember Hueso voted "no." Due to conflicts of interest resulting from the purchase of service credits, Councilmembers Maienschein, Madaffer, Atkins, and Frye were recused with Councilmember Frye selected as the fifth council member in a random drawing based on the legal doctrine/exception of legally required participation. Whether the 4 to 1 vote is binding on the City is a legal question that may have to be resolved by a court.
